COVID-19 Response is “Pretty Incredible”

The COVID-19 crisis has caused stress in everyone's lives. For children struggling with anxiety and other mental health issues, the pandemic has been especially difficult. As the coronavirus lockdown began, Bradley Hospital quickly mobilized to ensure uninterrupted care for the hundreds of children and families who depend on it every day. In a single week's time, Bradley Hospital transformed the entire outpatient program and some of the partial programs into a robust telemedicine service, among other measures to safeguard patients and providers.

“That was pretty incredible,” says Karyn Horowitz, MD, Director of Outpatient Child Psychiatry and Behavioral Health Services at Lifespan. “Staff was trained in telehealth and counseling on virtual platforms. We worked with corporate compliance, legal, and IT, and got consent forms from every family. It was an amazing team effort.”

Outpatient appointments decreased only slightly for that one week—and then began booming.

“Children and families are struggling more than ever,” Dr. Horowitz says. “The closing of schools has been particularly challenging because so many kids lost the daily structure and supports they need.”

The Bradley Learning Exchange, led by Marge Paccione, PhD, swung into high gear to cross train staff to fill in for staffing shortages. Dr. Paccione and her team also crafted and disseminated guidance resources for families, including the Rizzo Raccoon coronavirus coloring book, created in collaboration with art therapist Melissa Weaver, LMHC, ATR-BC. “We have the direct care of 164 children at the hospital and in group homes every day,” Dr. Horowitz says. “It's been all hands on deck.”
